Proposed Permit Coverage:

The proposed permit is a reissuance of a permit initially issued to Furie in 2014 to support natural gas production from a single production well from the Beluga formation at the Julius R. Platform. Today, there are four production wells completed into both the Beluga and Sterling formations. The inclusion of a treatment system and discharge of produced represents a critical modification proposed permit to mitigate hydrate formations in the gas pipeline to the onshore production facility that will allow for continued gas production from the Platform. During the term of the proposed permit, the following discharges will be authorized:

- Outfall 002A Deck drainage from the Julius R. Platform
- Outfall 002B Deck drainage from a Mobile Offshore Drilling Unit (MODU)
- Outfall 003A Domestic wastewater from the Julius R. Platform
- Outfall 003B Domestic wastewater from a MODU
- Outfall 004B Graywater overboard from a MODU
- Outfall 008A Fire control system test water from the Platform
- Outfall 009B Non-contact cooling water from a MODU
- Outfall 010B Uncontaminated ballast water from a MODU
- Outfall 015A Produced water from the Platform

The permit to discharge includes the authorization of chronic mixing zones for residual chlorine in domestic wastewater discharges from the platform and a MODU (combined Outfall 003A, Outfall 003B and Outfall 004B) and, when needed, in overboard graywater discharges from a MODU (Outfall 004B), for temperature in the non-contact cooling water discharge from a MODU (Outfall 009B), and for chronic toxicity in the produced water discharge (Outfall 015A).

Determination:

DEC proposes to reissue the above listed permit.

Public Comments:

Comments from the general public were accepted during the Public Notice periods from November 24 through December 28, 2021 and from January 11 through January 19, 2021. Additional comments will not be accepted during this review period.

Deadline for Written Applicant Review Comments:

The deadline for proposed final permit review comments by the applicant is:

February 19, 2021, 11:59 pm Alaska Standard time.
